BID OPENING DATE AND TIME

• Bid Opening Date Changes to 04/30/2018. Bid Opening Time shall remain unchanged.

ADDITIONAL SPECIFICATIONS

• Section 1.2(A) VENDOR LISTING, after the clause stating, "DHS shall have the option to extend the Qualified Vendor Listing on a year-to-year basis, for up to six (6) additional one year terms or portion thereof."

ADD

"Any changes to this RFQ deemed necessary by the agency before an extension is granted must be agreed to by the vendor before the extension is granted. A vendor will be notified by the agency of any changes to the RFQ in writing, which will include documentation for the vendor to sign acknowledging agreement to all changes. If a vender declines to agree to changes to the RFQ, the vendor shall be moved from the Qualified Vendor List at the end of the validity term."

After Section 1.19 (A)(B) PROHIBITION OF EMPLOYMENT OF ILLEGAL IMMIGRANTS

ADD

1.20 RESTRICTION OF BOYCOTT OF ISRAEL

- A. Pursuant to Arkansas Code Annotated § 25-1-503, a public entity **shall not** enter into a contract with a company unless the contract includes a written certification that the person or company is not currently engaged in, and agrees for the duration of the contract not to engage in, a boycott of Israel.
- B. This prohibition does not apply to a company which offers to provide the goods or services for at least twenty percent (20%) less than the lowest certifying business.
- C. By checking the designated box on the Proposal Signature Page of the response packet, a Contractor agrees and certifies that they do not, and will not for the duration of the contract, boycott Israel.

 Section 4.3(C) CONDITIONS OF CONTRACT, after the sentence ending with "and the Performance Based Contracting standards as presented in Attachment F."

ADD

"With the exception of Attachment F, the State will not entertain changes to this RFQ or any of the Attachments listed above."

CHANGE OF SPECIFICATIONS

- Section 1.14(F), delete: "with the exception of financial data,"
- Delete Section 1.17 MINORITY BUSINESS POLICY in its entirety and replace with the following:

MINORITY AND WOMEN-OWNED BUSINESS POLICY

- A. "Minority business enterprise" is defined by Arkansas Code Annotated § 15-4-303(3) as a business that is at least fifty-one percent (51%) owned by one (1) or more persons who are lawful permanent residents of the state of Arkansas and who are:
 - African American
 I
 - Pacific Islander American
 - American Indian
- A Service Disabled Veterans as designated by the United States Department of Veteran Affairs
- Asian American
- Hispanic American
- B. "Women-owned business enterprise" is defined by Arkansas Code Annotated § 15-4-303(9) as a business that is at least fifty-one percent (51%) owned by one (1) or more women who are lawful permanent residents of the state of Arkansas.
- C. The Arkansas Economic Development Commission conducts a certification process for minority and womenowned businesses as provided under the Minority and Women-Owned Business Economic Development Act, Arkansas Code Annotated § 15-4-301 et seq. The Contractor's Certification Number should be included on the *Proposal Signature Page*.
- Section 1.20 PAST PERFORMANCE now becomes Section 1.21 PAST PERFORMANCE
- Section 1.21 PUBLICITY now becomes Section 1.22 PUBLICTY
- Section 1.22 RESERVATION now becomes Section 1.23 RESERVATION
- Section 2.1(A) VENDOR QUALIFICATIONS, "This should include without limitation" shall now read: "This shall include without limitation:"
- Section 2.1(C) VENDOR QUALIFICATIONS, "The vendor should provide" shall now read: "The vendor shall provide:"
