DHS has implemented an enterprise service bus (ESB) framework using the IBM App Connect platform and as applications are rationalized and modernized, the replacements/upgrades should leverage the ESB for simple access to exposed data/services. Point of view is that aplications are either producers/consumers/both via the ESB. This requirement/standard works in conjunction with real time web-based interfaces requirement/standard above. An example might be that application 1 is the system of record for eligibility information for a program. Application 1 would publish (produce) that this information is available on the ESB making it available for consumption by other applications without point-to-point interfaces.

An example would be using a class or variable to represent a real word object or process, function, etc.
