# SECTION 1 - GENERAL INSTRUCTIONS AND INFORMATION

# 1.1 PURPOSE

This Invitation for Bid (IFB) is issued by the Department of Human Services (DHS), Office of Procurement (OP) for the Division of County Operations (DCO) to obtain pricing and a contract(s) for printing and mailing services.

# 1.2 INTERGOVERNMENTAL/COOPERATIVE USE OF PROPOSAL AND CONTRACT

In accordance with Arkansas Code §19-11-249, this proposal and resulting contract is available to any State Agency or Institution of Higher Education that wishes to utilize the services of the selected proposer, and the proposer agrees, they may enter into an agreement as provided in this solicitation.

# 1.3 TYPE OF CONTRACT

- A. A Term contract will be awarded to multiple vendors.
- B. Any resultant contract of this *Bid Solicitation* **shall** be subject to State approval processes which may include Legislative review.
- C. The term of this contract **shall** be for one (1) year. The anticipated starting date for the contract is December 1, 2023. Upon agreement by the vendor and agency the contract may be renewed by the Office of Procurement (OP) on a year-to-year basis, for up to six (6) additional one-year terms or a portion thereof not to exceed a total aggregate contract term of seven (7) years.

#### 1.4 ISSUING AGENCY

The OP, as the issuing office, is the sole point of contact throughout this solicitation process. Vendor questions regarding this Bid Solicitation should be made through the State's buyer as shown on page two of this document. Vendor's questions will be answered as a courtesy and at vendor's own risk.

### 1.5 BID OPENING LOCATION

Bids submitted by the opening time and date shall be opened at the following location:

Department of Human Services Office of Procurement 700 Main Street Little Rock, AR 72201

Vendors wishing to attend the bid opening must report to the main entrance location, Arkansas Department of Human Services, Donaghey Plaza South Building, 700 Main Street, Little Rock, Arkansas 72201 and check in with the receptionist. All attendees are required to obtain security clearance upon entrance to the building by submitting a current, valid photo ID, preferably a driver's license, to the Security Officer at the reception area. The Security Officer will issue a visitor's badge which must be worn at all times. Before leaving the bid opening, visitors are required to return the visitor's badge to the Security Officer and retrieve their ID. The receptionist is to contact the buyer, for the vendor, for more detailed directions to the bid opening location.

When circumstances warrant, DHS may elect to conduct the bid opening entirely via video conference. If DHS makes this election, DHS shall post a link to the video conference on its website. If the bid opening will be conducted entirely via video conference, individuals will not be permitted to attend in-person.

#### 1.6 DEFINITION OF REQUIREMENT

- A. The words "**must**" and "**shall**" signify a Requirement of this solicitation and that vendor's agreement to and compliance with that item is mandatory.
- B. Exceptions taken to any Requirement in this *Bid Solicitation*, whether submitted in the vendor's bid or in subsequent correspondence, **shall** cause the vendor's bid to be disqualified.

#### 1.7 DEFINITION OF TERMS

A. The State Procurement Official has made every effort to use industry-accepted terminology in this *Bid Solicitation* and will attempt to further clarify any point of an item in question as indicated in *Clarification of Bid Solicitation*.

- B. The words "bidder," "vendor," and "contractor" are used synonymously in this document.
- C. The terms "Invitation for Bid", "IFB" and "Bid Solicitation" are used synonymously in this document.
- D. The terms "Normal Inside Delivery" means delivery to a building with or without an accessible dock where the product ordered is brought into the building by the delivery driver to specific rooms or areas.

#### 1.8 RESPONSE DOCUMENTS

- A. Bid Response Packet
  - An official authorized to bind the vendor(s) to a resultant contract must sign the Bid Signature Page.
  - 2. Vendor's signature on this page **shall** signify vendor's agreement that either of the following **shall** cause the vendor's bid to be disqualified:
    - a. Additional terms or conditions submitted intentionally or inadvertently.
    - b. Any exception that conflicts with a Requirement of this *Bid Solicitation*.
  - 3. The following items **shall** be submitted with the *Bid Response Packet in a sealed envelope*:
    - a. EO 98-04 Disclosure Form (Attachment A).
    - b. Copy of Vendor's Equal Opportunity Policy. (See Equal Opportunity Policy.)
    - c. Signed addenda to this IFB, if applicable. (See Requirement of Addendum.)
    - d. Documentation that vendor meets the minimum qualifications outlined in this IFB. (See *Minimum Qualifications*.)
  - 4. DO NOT include any other documents or ancillary information, such as a cover letter or promotional/marketing information. Submit one (1) electronic copy of the response packet, excluding the Official Bid Price Sheet, preferably on a flash drive and one (1) hard copy. To the extent possible, all electronic files should be a single document in PDF format.
- B. Official Bid Price Sheet. (See Pricing.)
  - 5. Vendor's original Official Bid Price Sheet must be submitted in hard copy format.
  - 6. Vendor should also submit one (1) electronic copy of the *Official Bid Price Sheet*, preferably on a flash drive, in a single PDF file.
  - 7. The Official Bid Price Sheet, including the hard copy and electronic copy, **must** be separately sealed from the Bid Response Packet and should be clearly marked as "Pricing." Vendor must not include any pricing in the hard copies or electronic copies of the Bid Response Packet.

# 1.9 AGREEMENT AND COMPLIANCE PAGES

A. Vendor **must** sign all *Agreement and Compliance Pages* relevant to each section of the *Bid Solicitation Document*. The *Agreement and Compliance Pages* are included in the Bid *Response Packet*.

B. Vendor's signature on these pages **shall** signify agreement to and compliance with all requirements within the designated section.

#### 1.10 CLARIFICATION OF BID SOLICITATION

- A Contractor may submit written questions requesting clarification of information contained in this *Bid Solicitation*. Written questions should be submitted by 4:00 p.m., Central Time on February 21,2023. Submit written questions by email to the buyer as shown on page one (1) of this *Bid Solicitation*.
- B. The attached response template (*Attachment B*) **must** be used for submission of all written questions. All questions should include the information specified in the response template. Written questions submitted in a different format may not be answered by DHS.
- C. Contractor's written questions will be consolidated and responded to by the State. The State's consolidated written response is anticipated to be posted to the OP website by the close of business on March 3, 2023.
- D. Answers to verbal questions may be given as a matter of courtesy and **must** be evaluated at contractor's risk.

#### 1.11 SUBCONTRACTORS

- A. Vendor **must** complete, sign, and submit the *Proposed Subcontractors Form* included in the *Bid Response Packet* to indicate vendor's intent to utilize, or to not utilize, subcontractors.
- B. Additional subcontractor information may be required or requested in following sections of this *Bid Solicitation*. **Do not** attach any additional information to the *Proposed Subcontractors Form*.
- C. The utilization of any proposed subcontractor is subject to approval by the State agency.

#### 1.12 PRICING

- A. Vendor(s) **must** include all pricing on the Official Bid Price Sheet(s) only. Any cost not identified by the successful vendor but subsequently incurred in order to achieve successful operation **shall** be borne by the vendor. The *Official Bid Price Sheet* is provided in the Bid Response Packet.
- B. A justification of prices quoted should be attached to the Official Bid Price Sheet.
- C. To allow time to evaluate bids, prices **must** be valid for one hundred twenty (120) days following the bid opening.
- D. Failure to complete and submit the *Official Bid Price Sheet* **shall** result in disqualification.
- E. All bid pricing **must** be in United States dollars and cents.
- F. The Official Bid Price Sheet may be reproduced as needed.
- G. The Official Bid Price Sheet and accompanying price justification **must** be separately sealed from the Bid Response Packet.

# 1.13 PRIME CONTRACTOR RESPONSIBILITY

- A. A joint bid submitted by two (2) or more vendors is acceptable. However, a single vendor **must** be identified as the prime contractor.
- B. The prime contractor **shall** be held responsible for the contract and **shall** be the sole point of contact.

### 1.14 INDEPENDENT PRICE DETERMINATION

A. By submission of this bid, the vendor certifies, and in the case of a joint response, each party thereto certifies as to its own organization, that in connection with this bid:

- 1. The prices in the bid have been arrived at independently, without collusion.
- 2. No prior information concerning these prices has been received from, or given to, a competitive company.

B. Evidence of collusion **shall** warrant consideration of this bid by the Office of the Attorney General. All vendors **shall** understand that this paragraph may be used as a basis for litigation.

#### 1.15 PROPRIETARY INFORMATION

- A. Submission documents pertaining to this *Bid Solicitation* become the property of the State and are subject to the Arkansas Freedom of Information Act (FOIA).
- B. In accordance with FOIA and to promote maximum competition in the State competitive bidding process, the State may maintain the confidentiality of certain types of information described in FOIA. Such information may include trade secrets defined by FOIA and other information exempted from the Public Records Act pursuant to FOIA.
- C. Prospective Contractor may designate appropriate portions of its response as confidential, consistent with and to the extent permitted under the Statutes and Rules set forth above, by submitting a redacted copy of the response.
- D. By redacting any information contained in the response, the Prospective Contractor warrants that it has formed a good faith opinion having received such necessary or proper review by counsel and other knowledgeable advisors that the portions redacted meet the requirements of the Rules and Statutes set forth above.
- E. Under no circumstances will pricing information be designated as confidential.
- F. One (1) complete copy of the submission documents from which any proprietary information has been redacted should be submitted on a flash drive in the *Bid Response Packet*. A CD is also acceptable. Do not submit documents via email or fax.
- G. Except for the redacted information, the redacted copy **must** be identical to the original hard copy, reflecting the same pagination as the original and showing the space from which information was redacted.
- H. The Prospective Contractor is responsible for identifying all proprietary information and for ensuring the electronic copy is protected against restoration of redacted data.
- The redacted copy will be open to public inspection under FOIA without further notice to the Prospective Contractor.
- J. If a redacted copy of the submission documents is not provided with Prospective Contractor's *Bid Response Packet*, a copy of the non-redacted documents, with the exception of financial data (other than pricing), will be released in response to any request made under FOIA.
- K. If the State deems redacted information to be subject to FOIA, the Prospective Contractor will be contacted prior to release of the documents.
- L. The State has no liability to a Prospective Contractor with respect to the disclosure of Prospective Contractor's confidential information ordered by a court of competent jurisdiction pursuant to FOIA or other applicable law.

#### 1.16 CAUTION TO VENDORS

- A. Prior to any contract award, all communication concerning this Bid Solicitation must be addressed through OP.
- B. Vendor **must not** alter any language in any solicitation document provided by the State.
- C. Vendor must not alter the Official Bid Price Sheet.

D. All official documents and correspondence related to this solicitation **shall** be included as part of the resultant contract.

- E. Bids **must** be submitted in the English language.
- F. The State **shall** have the right to award or not award a contract, if it is in the best interest of the State to do so.
- G. Vendor must provide clarification of any information in their response documents as requested by OP.
- H. Bids must meet or exceed all defined specifications as set forth in this Bid Solicitation.
- I. Bids **must** meet all terms and conditions of this Invitation for Bid and the laws of the State of Arkansas.
- J. Vendors may submit multiple bids.

# 1.17 REQUIREMENT OF ADDENDUM

- A. This Bid Solicitation shall be modified only by an addendum written and authorized by OP.
- B. An addendum posted within three (3) calendar days prior to the bid opening **shall** extend the bid opening and may or may not include changes to the Bid Solicitation.

#### 1.18 AWARD PROCESS

# A. Vendor Selection

- 1. Award will be made to lowest responsible, responsive bidder(s) based on unit price per line item (Official Bid Price Sheet Items 1 and 2). Bidders **must** meet minimum qualifications. Bids must meet or exceed all defined specifications. Bids **must** meet all terms and conditions of this Invitation for Bid and the laws of the State of Arkansas.
- 2. Contract award, extension, or renewal is contingent upon approval by DHS officials, subsequent approval by the OP, review by the Legislative Council and the availability of State funds. Changes to any non-financial portion of this agreement may be made with the agreement of both DHS and the Contractor.

# B. Negotiations

- If the State so chooses, negotiations may be conducted with the lowest responsive bidder(s).
   Negotiations are conducted at the sole discretion of the State.
- 2. If negotiations fail to result in a contract, the State may begin the negotiation process with the next lowest responsive bidder. The negotiation process may be repeated until the lowest responsive vendor has been determined, or until such time the State decides not to move forward with an award.

# C. Anticipation to Award

- 1. Once anticipated successful vendor(s) has been determined, the anticipated award will be posted on the following websites:

- 2. The anticipated award will be posted for a period of fourteen (14) days prior to the issuance of a contract. Vendors and agencies are cautioned that these are preliminary results only, and a contract will not be issued prior to the end of the fourteen (14) day posting period.

3. OP **shall** have the right to waive the policy of Anticipation to Award when it is in the best interest of the State.

4. It is the vendor's responsibility to check the above referenced websites for the posting of an anticipated award.

### D. Issuance of Contract

- 1. Any resultant contract of this Bid Solicitation **shall** be subject to State approval processes which may include Legislative review.
- 2. An Office of Procurement Official will be responsible for award and administration of any resulting contract.
- 3. DHS intends to receive services with the least overall expense to the State. The lowest vendor for each line item will be contacted first. If the lowest vendor is unable to provide services in the timeframe required, DHS may contact both vendors to ensure services are provided.

# 1.19 MINORITY AND WOMEN-OWNED BUSINESS POLICY

- A. A minority-owned business is defined by Arkansas Code Annotated § 15-4-303 as a business that is at least fifty-one percent (51%) owned by a lawful permanent resident of this State who is:
  - African American
  - American Indian
  - Asian American
  - Hispanic American
- Pacific Islander American
- A Service-disabled Veteran as designated by the United States Department of Veterans Affairs
- B. A woman-owned business is defined by Arkansas Code Annotated § 15-4-303(9) as a business that is at least fifty-one percent (51%) owned by one (1) or more women who are lawful permanent residents of this State.
- C. The Arkansas Economic Development Commission conducts a certification process for minority-owned and women-owned businesses. If certified, the Prospective Contractor's Certification Number should be included on the Bid Signature Page.

# 1.20 EQUAL EMPLOYMENT OPPORTUNITY POLICY

- A. In compliance with Arkansas Code Annotated § 19-11-104, the State is required to have a copy of the anticipated Contractor's *Equal Opportunity (EO) Policy* prior to issuing a contract award.
- B. EO Policies should be included as a hardcopy accompanying the solicitation response.
- C. The submission of an *EO Policy* to the OP is a one-time requirement. Vendors are responsible for providing updates or changes to their respective policies, and for supplying *EO Policies* upon request to other State agencies that must also comply with this statute.
- D. Vendors, who are not required by law by to have an EO Policy, must submit a written statement to that effect.

# 1.21 PROHIBITION OF EMPLOYMENT OF ILLEGAL IMMIGRANTS

- A. Pursuant to Arkansas Code Annotated § 19-11-105, prior to the award of a contract, selected vendor(s) **must** have a current certification on file with the OP stating that they do not employ or contract with illegal immigrants.
- B. OP will notify the selected vendor(s) prior to award if their certification has expired or is not on file. Instructions for completing the certification process will be provided to the vendor(s) at that time.

# 1.22 RESTRICTION OF BOYCOTT OF ISRAEL

A. Pursuant to Arkansas Code Annotated § 25-1-503, a public entity **shall not** enter into a contract with a company unless the contract includes a written certification that the person or company is not currently engaged in and agrees for the duration of the contract not to engage in, a boycott of Israel.

B. This prohibition does not apply to a company which offers to provide the goods or services for at least twenty percent (20%) less than the lowest certifying business.

C. By checking the designated box on the Bid Signature Page of the response packet, a Prospective Contractor agrees and certifies that they do not, and will not for the duration of the contract, boycott Israel.

#### 1.23 PAST PERFORMANCE

In accordance with provisions of State Procurement Law, specifically OSP Rule R5:19-11-230(b)(1), a vendor's past performance with the State may be used to determine if the vendor is "responsible." Proposals submitted by vendors determined to be non-responsible **shall** be disqualified.

#### 1.24 TECHNOLOGY ACCESS

- A. When procuring a technology product or when soliciting the development of such a product, the State of Arkansas is required to comply with the provisions of Arkansas Code Annotated § 25-26-201 et seq., as amended by Act 308 of 2013, which expresses the policy of the State to provide individuals who are blind or visually impaired with access to information technology purchased in whole or in part with state funds. The Prospective Contractor expressly acknowledges and agrees that state funds may not be expended in connection with the purchase of information technology unless that technology meets the statutory requirements found in 36 C.F.R. § 1194.21, as it existed on January 1, 2013 (software applications and operating ICSs) and 36 C.F.R. § 1194.22, as it existed on January 1, 2013 (web-based intranet and internet information and applications), in accordance with the State of Arkansas technology policy standards relating to accessibility by persons with visual impairments.
- B. Accordingly, the Prospective Contractor expressly represents and warrants to the State of Arkansas through the procurement process by submission of a Voluntary Product Accessibility Template (VPAT) for 36 C.F.R. § 1194.21, as it existed on January 1, 2013 (software applications and operating ICSs) and 36 C.F.R. § 1194.22, that the technology provided to the State for purchase is capable, either by virtue of features included within the technology, or because it is readily adaptable by use with other technology, of:
  - 1. Providing, to the extent required by Arkansas Code Annotated § 25-26-201 et seq., as amended by Act 308 of 2013, equivalent access for effective use by both visual and non-visual means.
  - 2. Presenting information, including prompts used for interactive communications, in formats intended for non-visual use.
  - 3. After being made accessible, integrating into networks for obtaining, retrieving, and disseminating information used by individuals who are not blind or visually impaired.
  - 4. Providing effective, interactive control and use of the technology, including without limitation the operating system, software applications, and format of the data presented is readily achievable by nonvisual means.
  - 5. Being compatible with information technology used by other individuals with whom the blind or visually impaired individuals interact.
  - 6. Integrating into networks used to share communications among employees, program participants, and the public.
  - 7. Providing the capability of equivalent access by nonvisual means to telecommunications or other interconnected network services used by persons who are not blind or visually impaired.
- C. State agencies cannot claim a product as a whole is not reasonably available because no product in the marketplace meets all the standards. Agencies must evaluate products to determine which product best meets the standards. If an agency purchases a product that does not best meet the standards, the agency must provide written documentation supporting the selection of a different product, including any required reasonable accommodations.
- D. For purposes of this section, the phrase "equivalent access" means a substantially similar ability to communicate with, or make use of, the technology, either directly, by features incorporated within the

technology, or by other reasonable means such as assistive devices or services which would constitute reasonable accommodations under the Americans with Disabilities Act or similar state and federal laws. Examples of methods by which equivalent access may be provided include, but are not limited to, keyboard alternatives to mouse commands or other means of navigating graphical displays, and customizable display appearance. As provided in Arkansas Code Annotated § 25-26-201 et seq., as amended by Act 308 of 2013, if equivalent access is not reasonably available, then individuals who are blind or visually impaired **shall** be provided a reasonable accommodation as defined in 42 U.S.C. § 12111(9), as it existed on January 1, 2013.

E. If the information manipulated or presented by the product is inherently visual in nature, so that its meaning cannot be conveyed non-visually, these specifications do not prohibit the purchase or use of an information technology product that does not meet these standards.

# 1.25 COMPLIANCE WITH THE STATE SHARED TECHNICAL ARCHITECTURE PROGRAM

The respondent's solution must comply with the state's shared Technical Architecture Program which is a set of policies and standards that can be viewed at <a href="https://www.dfa.arkansas.gov/intergovernmental-services/state-technology-cost-analysis/architecture-compliance/">https://www.dfa.arkansas.gov/intergovernmental-services/state-technology-cost-analysis/architecture-compliance/</a>. Only those standards which are fully promulgated or have been approved by the Governor's Office apply to this solution.

#### 1.26 MASTERCARD ACCEPTANCE

- A. Awarded vendor should have the capability of accepting the State's authorized MASTERCARD Procurement Card (p-card) as a method of payment.
- B. Price changes or additional fee(s) **shall not** be levied against the State when accepting the p-card as a form of payment.
- C. MASTERCARD is not the exclusive method of payment.

#### 1.27 PUBLICITY

- A. Vendors **shall not** issue a news release pertaining to this *Bid Solicitation* or any portion of the project without OP's prior written approval.
- B. Failure to comply with this Requirement shall be cause for a vendor's bid to be disqualified.

### 1.28 RESERVATION

The State **shall not** pay costs incurred in the preparation of a bid.

Additional days can be proclaimed as holidays by the Governor through executive proclamation. State offices are normally closed on holidays however, there are occasions (i.e. during legislative sessions) when it may become necessary to keep state offices open on holidays. The Contractor shall maintain adequate staff on such working holidays.

# **SECTION 2 – MINIMUM REQUIREMENTS**

#### 2.1 INTRODUCTION

This Invitation for Bid (IFB) is issued by the Department of Human Services (DHS), Office of Procurement (OP) for the Division of County Operations (DCO) to obtain pricing and a contract(s) for printing and mailing services.

DHS, at its sole discretion, reserves the right to request services for additional DHS divisions and locations.

### 2.2 BACKGROUND

DHS provides and pays for many types of benefits and social services and is required to provide notices to Arkansans applying for and receiving benefits for Health Care Programs, the Supplemental Nutrition Assistance Program (SNAP), or Transitional Employment Assistance (TEA) program. Notices may include various information related to each program. Notices are generated through the Arkansas Integrated Eligibility System (ARIES) and files are sent to the Contractor for printing and mailing. Such notices are referred throughout this Section and on the Official Bid Price Sheet as ARIES Notices.

There are about one (1) million Medicaid recipients, between 250,000 – 300,000 SNAP recipients, and 2,500 TEA recipients.

### 2.3 SERVICE DELIVERY LOCATION

All services **must** be provided during normal state work hours and within the agreed upon number of days unless otherwise arranged and coordinated with the agency. The vendor shall give the agency immediate notice of any anticipated delays that will affect the service delivery requirement.

#### 2.4 MINIMUM QUALIFICATIONS

The Contractor **must** meet the following requirements:

- A. The Contractor **must** be registered to do business in the State of Arkansas. For verification purposes, Contractor **must** submit official documentation of their active registration from the Arkansas Secretary of State's Office.
- B. The bidder **must** include a copy of all required licensure and certification documents in the bidder's response to this solicitation. See "Response Documents."
- C. The Contractor **must** have a MASS<sup>™</sup> certification from the United States Postal Services (USPS). For verification purposes, Contractor **must** submit a copy of the certification with bid submission.
- D. The Contractor **must** have at least three (3) years of experience with Print and Mail Processing Services. For verification purposes, Contractor **must** provide three (3) references from different accounts, either commercial or governmental within the United States, of similar size and scope to that of this IFB. At minimum, references **must** include:
  - Organization Name
  - Address
  - Contact person name, email address, and phone number
  - · Project description and dates
- E. The Contractor **must** have the ability to meet deadlines such as drop off and mailing as requested by DHS. The Contractor **must** provide, with bid submission, a detailed work plan including, without limitation, the following:
  - Hours of Operation
  - Describe how the Prospective Contractor will meet all deadlines such as drop off and delivery including a
    contingency plan that specifies how requests will be met for those that may be outside of normal business
    hours. Process for sorting mail
  - Prioritizing DHS requests
  - Describe how Prospective Contractor will verify each piece of mail was sent out on time such as applying a date stamp to each piece of mail

# 2.5 SCOPE OF WORK

DHS/DCO requires print and mail processing of a variety of mail on a daily, monthly, annual, and ad hoc basis. Processing requirements include the following:

- · ability to complete large-scale projects in a timely, transparent, and efficient manner
- receipt of files via secure method as approved by DCO
- · single-sided and duplex printing
- · black and white, grayscale, and color printing
- printing variable data throughout multipage files
- Optical Character Reader (OCR) print/copy capabilities and software
- · binding by stapling or booklet
- sorting Multiline Optical-Character Reader (MLOCR)
- bar coding
- folding
- inserting
- meterina
- · delivery to mailing entities
- address and return address printing on envelopes and/or labels

DCO requires receiving services, inventory management, and storage of DHS provided supplies (such as envelopes and forms required for inserts).

### 2.6 TRANSITIONING

A. Upon contract award, the Contractor **must** work with DHS/DCO and other organizations and staff as designated by DHS to ensure an orderly transition of services and responsibilities. Contractor **shall** be fully operational by October 1, 2023. Contractor may be subject to contractual nonperformance damages determined by DHS. DHS, within its sole discretion, may amend the above deadline. Upon expiration, termination, or cancellation of the contract, the Contractor **shall** assist DHS/DCO to ensure an orderly and smooth transfer of responsibility and continuity of those services required under the terms of the contract to an organization designated by DHS.

# 2.7 INSURANCE

- A. The Contractor must maintain the following insurance coverages throughout the duration of the contract:
  - Umbrella/Excess Liability (Each occurrence and aggregate) \$2,000,000
  - Business/Automobile Liability (Each accident): \$1,000,000
  - Commercial General Liability (Each occurrence): \$1,000,000
  - Crime/Fidelity (Theft, Forgery, & Property Crime): \$1,000,000
  - Workers Compensation in compliance with Arkansas law
- B. The Contractor shall provide certificate of insurance upon request by DHS.
- C. The Contractor **shall** provide written notice of cancellation or policy changes to DHS thirty (30) days prior to the cancellation or change(s).

#### 2.8 COMPLIANCE

- A. The Contractor **must** comply with all current and subsequent USPS rules, policies, and procedures, as well as State and Federal statutes that apply to handling mail.
- B. Services **shall** be performed using the best practices methodology in accordance with all applicable laws, statutes, and procedures in providing mail services and mail related ancillary services.
- C. The Contractor **must** adhere to printing and document management best practices and meet minimum industry standards for full-service printing and mail processing.
- D. Contractor, subcontractor(s), and personnel **must** comply with federal and state laws and regulations, including without limitation: Health Insurance Portability Accountability Act (HIPAA), Arkansas Personal Information Protection Act, Health Information Technology for Economic and Clinical Health Act (HITECH), Americans with Disabilities Act (ADA), and Privacy Act.

E. If any federal or state statute or regulation is enacted which requires a change in this IFB or any attachment, both parties will deem this contract and any attachment automatically amended to comply with the newly enacted statute or regulation as of its effective date.

F. In the event of a conflict between these standards and other applicable state, local, or federal laws, rules, or standards, the stricter requirement shall apply.

#### 2.9 PRINTING

A. The Contractor **must** print, sort, fold, insert, and mail documents as requested by DHS. Items to be digitally printed may include, without limitation: Aries Notices, basic client notices, fliers, multi-part mailers, and ad hoc requests.

# B. Aries Notices

Daily (200,000)

Monthly (5,000,000)

Contractor must complete DHS ARIES Notices requests within the same business day, unless otherwise specified by DHS.

# C. Ad Hoc and Annual Requests

The Contractor **shall** complete ad hoc and annual requests that may include eligibility system and related notices. Ad Hoc and Annual Requests **must** be printed and mailed within twenty-four (24) hours of receipt of request:

D. Any other special request that **must** be printed and mailed at the request of DHS.

#### 2.10 QUALITY

- A. All material provided **shall** be of good quality. Concise registration, consistent ink coverage and density, and accurate folding. Accurate trimming is to be even with no jagged or torn edges. Obvious production defects are reasons for possible rejection of materials.
- B. DHS reserves the right to inspect printed materials and determine if it meets the quality, requirements, and standards of the contract. If, in the opinion of DHS, the material is unacceptable, DHS may request to reprint the material within a specified time frame.

# 2.11 MAILING: OUTBOUND AND INBOUND PROCESSING

- A. Notices **must** be inserted into envelopes and mailed directly to the homes of Arkansans in accordance with DHS policies governing the schedule.
- B. Contractor must use U.S. Postal Service certification software or equivalent for presorting of mail.
- C. Over the period of this contract DHS may add additional forms; delete forms, increase quantities, decrease quantities, and change processing schedule. The Contractor should state any anticipated limitations in meeting such changing needs.
- D. The Contractor **must** ensure all processed items are either picked up by the mailing entity or delivered to the mailing entity the same business day. To date, all mailed materials have been delivered via the United States Postal Service (USPS), but the Contractor **must** be able to accommodate other reasonable mailing entities (UPS or FedEx). Any/all related transportation charges (pick-up, deliver, etc.) will be the Contractor's responsibility and **must** be included as part of their response.
- E. The Contractor **must** have the ability to accept postage warrants from DHS to apply postage to mailings either using the DHS Postal Permit number or by applying postage directly. The Contractor **must** have the ability to report postage by job and to provide DHS with sufficient (at least one (1) week) notice when postage account reimbursement is required, if applicable.
- F. The Contractor **must** identify the date mailed on each piece of mail.

### 2.12 GENERAL REQUIREMENTS

The Contractor **must** absorb all one-time costs associated with accepting this contract, including but not limited to, moving forms stored at the current Vendor's location to the successful Contractor's location prior to the beginning of the contract.

### 2.13 EQUIPMENT AND SUPPLIES

- A. The Contractor shall provide all personnel, equipment, software, supplies, transportation, and all other items necessary to perform this contract for print and mail processing services. Equipment and machinery shall include, but not limited to all necessary equipment for mail processing; high volume inserters, high volume mail sorters, mailing machines, postage meters, folders, postage tracking systems, printers with at least 250 PPM capacity, and other machines that offer automated processing. Contractor **must** ensure that print equipment has the necessary built-in or add-on capability for OCR characters. The Contractor will document which processes are completed manually by staff.
- B. The Contractor **shall** be responsible for maintaining all equipment in good working order in accordance with the manufacturer's specifications and/or industry standard.
- C. The Contractor **shall** provide and be responsible for all appropriate vehicles, licensure, registrations, gasoline and maintenance of vehicles and all associated costs with the operation of vehicles.
- D. The Contractor **shall** assume full responsibility for the mail and its contents from the time of pick-up until such time as the mail is in the possession of the United States Postal Service (USPS).
- E. The Contractor **must** ensure that the best possible class selection is chosen for all out-going mail based on cost, policy, timeliness, and delivery requirements. In no circumstances shall the Contractor charge more postage per mail piece than currently approved by USPS.
- F. The Contractor **must** accept deliveries of DCO mail processing supplies at the Contractor's location. DCO will notify the Contractor of items to be delivered, the approximate quantity, and the approximate delivery time. The Contractor **must** notify the appropriate contact below when deliveries are received and forward any receipts or related paperwork to DCO within five (5) calendar days of receipt. Receipts can be mailed, delivered in person, or faxed.

# 2.14 ENVELOPES

- A. DHS will provide printed envelopes for mailing. In the event of stock shortage, DHS reserves the right to request additional printed envelopes.
- B. Upon request, the Contractor **must** provide the following printed envelopes for mailing ARIES and ad hoc notices (*Refer to Attachment H*)
  - 1. #10 all-purpose, commercial window envelope: 4 1/8" width x 9 ½" length single window
    - Adhesive: dry gum (no self-seal)
    - Commercial Flap (on top)
    - Weight: 24#
    - Window size: 3" x 4 ½"
    - Window Position: ½" from left fold 5/8" from bottom fold
    - Inside Tint: Standard Black Security Tint required
    - Print Color: 193 RedPrint Font: 14 pt. Calibri
  - 2. White booklet with vertical window envelope: 9" length x 12" width
    - Adhesive: dry gum (no self-seal)
    - Flap on top
    - Weight: 28#
    - Window size: 2.875" x 4.5"
    - Window Placement: 1" from the left-hand side and 1.375" from the top of the envelope
    - Inside Tint: Standard Black Security Tint required
    - Print Ink: 193 Red
    - Print Placement (front only): .5" from window and 2.2" from top of envelope

Note: DHS reserves the right to request additional envelopes for stock purposes.

- C. Delivery: FOB Destination, Freight Paid, and Normal Inside Delivery
  All deliveries **must** be made during normal state work hours and within twenty (20) business days after receipt
  of the order unless otherwise arranged and coordinated with DHS and stated on the Official Bid Price Sheet.
  The Contractor **must** give DHS immediate notice of any anticipated delays that will affect the delivery. DHS
  may request a rush delivery of less than thirty (30) business days.
  - 1. All transportation expenses for delivery of the envelopes **shall** be the responsibility of the Contractor.
  - 2. Delivery location will be provided on each purchase order.
- D. Loss or damage that occurs prior to the order being received by DHS, is the Contractor's responsibility. All orders must be properly packaged to prevent damage.

#### 2.15 MAILING FACILITIES

The Contractor's facility **must** be operational, at minimum, five (5) days per week, ten (10) hours per day unless otherwise agreed upon with DHS. The Contractor **must** have the ability to work outside hours of operation to complete requests within the same business day.

#### 2.16 COMMUNICATION

The Contractor **must** provide a central point of contact which shall include:

- the contact individual's name,
- · office phone number,
- · cellphone number
- · and email address

Sufficient backup contact information, (at least 2 contacts), **must** also be established so that inquiries concerning mail processing status are responded to within two (2) hours of contact by DCO. The contact information **must** be provided to DHS/DCO before the contract begins.

### 2.17 TIMELINESS REQUIREMENTS

A. ARIES notices **must** be processed on the same business day of receipt of the file unless otherwise specified by DHS.

Note: "Processed" for the purposes of this scope of work means printed, stuffed, and mailed.

- B. AD Hoc and annual requests **must** be processed within twenty-four (24) hours of receipt of the request unless otherwise specified by DHS. Along with ad hoc requests, regular mail must be processed the same day as received.
- C. Most items processed by DHS are extremely time sensitive. If the Contractor is unable to meet this requirement, the Contractor **must** notify DCO's technical contact (and/or designee) by phone <u>and</u> email when the Contractor suspects a delay in service. The Contractor **must** provide detailed explanation in writing to describe reason(s) for delay and proposed resolution(s).

# 2.18 STORAGE AND INVENTORY MANAGEMENT

The Contractor **must** provide ongoing climate-controlled storage at their facility to prevent damage to materials. DHS will not pay a separate storage or inventory management fee. The storage capacity **must** be based on the estimated volume of materials to accommodate DHS' processing needs. The Contractor **must** provide, on a weekly basis, an inventory listing of DHS' materials stored at their facility. The inventory report **must** be:

- 1. In a format agreed upon by both DCO and the Contractor. Format **must** be provided in the same manner for each submission.
- 2. Provided weekly every Tuesday by close of business or upon request to the DCO's technical contact person.

# 2.19 DAILY LOG

- A. For auditing purposes, the Contractor **must** maintain a daily log of materials that are received and processed. This log **must** include, without limitation, the following limitation:
  - form number, form name, quantity received, receipt date and time, quantity processed, process completion date and time (time to Postal Service, if applicable)
  - a detailed description of the work completed since the last update

- · any challenges that were encountered
- planned activities until the next scheduled update.
- Number of envelopes
- Number of notices
- B. A copy of this log **shall** be provided to DHS upon request.

#### 2.20 REPORTING

If requested, the Contractor must provide daily access to reports through a secure and protected server.

# 2.21 FILE TRANSFERS

DHS will generally be responsible for delivery of materials and electronic files to the Contractor for processing. Occasionally, an outside vendor may deliver materials or electronic files for processing.

# 2.22 INFORMATIONTECHNOLOGY

Contractors **shall** comply with and adhere to the State IT Security Policy and Standards. These policies may be revised from time to time and the Contractor **shall** comply with all such revisions. Updated and revised versions of the State IT Policy and Standards shall be made available to the Contractor.

The Contractor shall not connect any of its own equipment to a State LAN/WAN without prior written approval by the State. The Contractor **shall** complete any necessary paperwork as directed and coordinated with the Agency Director to obtain approval by the State to connect Contractor-owned equipment to a State LAN/WAN.

#### 2.23 PERFORMANCE STANDARDS

- A. <u>State law requires that all contracts for services include Performance Standards for measuring the overall</u> quality of services provided. *Attachment C: Performance-Based Contracting* identifies expected deliverables, performance measures, or outcomes; and defines the acceptable standards a vendor **must** meet to avoid assessment of damages.
- B. The State may be open to negotiations of Performance Standards prior to contract award, prior to the commencement of services, or at times throughout the contract duration.
- C. The State **shall** have the right to modify, add, or delete Performance Standards throughout the term of the contract, should the State determine it is in its best interest to do so. Any changes or additions to performance standards will be made in good faith following acceptable industry standards and may include the input of the vendor so as to establish standards that are reasonably achievable.
- D. All changes made to the Performance Standards shall become an official part of the contract.
- E. Performance Standards **shall** continue throughout the term of the contract.
- F. Failure to meet the minimum Performance Standards as specified **may** result in the assessment of damages or termination of the contract.
- G. In the event a Performance Standard is not met, the vendor will have the opportunity to defend, respond to, or cure to as determined by the State, the insufficiency. The State may waive damages if it determines there were extenuating factors beyond the control of the vendor that hindered the performance of services or it is in the best interest of the State. In these instances, the State shall have final determination of the performance acceptability.
- H. Should any compensation be owed to the agency due to the assessment of damages, vendor **shall** follow the direction of the agency regarding the required compensation process.

# **SECTION 3 – GENERAL CONTRACTUAL REQUIREMENTS**

Do not provide responses to items in this section.

### 3.1 PAYMENT AND INVOICE PROVISIONS

A. All invoices **must** be forwarded to the Arkansas Department of Human Services, Division of County Operations via email at: <a href="mailto:oppdfinancial@dhs.arkansas.gov">oppdfinancial@dhs.arkansas.gov</a> unless otherwise instructed by DHS. Mailed or faxed invoices will not be accepted.

- B. Invoices **must** be submitted within ten (10) calendar days of the end of each month. Each invoice **must** include:
  - Purchase Order Number
  - Form number(s) and form names that were processed
  - Services utilized
  - Number of pieces processed
- C. All invoices **must** provide detailed information to meet DCO's cost allocation needs by each print job. If a correction to an invoice is required, the corrected invoice **must** be received within one (1) business day.
- D. This contract **must** allow DHS to take advantage of postal discounts. The Contractor **shall** credit fifty percent (50%) of the amount discounted by the USPS. Reimbursement payments **shall** be paid to the DHS/DCO. In addition, the Contractor **must** provide a monthly reimbursement report detailing the refund.
- E. If the United States Postal Service makes material changes to the postage rates or regulations, DHS may permit the fees for services which are directly affected thereby to be revised. Any such revision **shall** be limited to the actual amount of the direct cost caused by the United States Postal Service changes.
- F. Payment will be made in accordance with applicable State of Arkansas accounting procedures upon acceptance goods and services by the agency.
- G. The State shall not be invoiced in advance of delivery and acceptance of any goods or services.
- H. Payment will be made only after the vendor has successfully satisfied the agency as to the reliability and effectiveness of the goods or services purchased as a whole.
- I. Other sections of this Bid Solicitation may contain additional requirements for invoicing.
- J. Selected vendor **must** be registered to receive payment and future *Bid Solicitation* notifications. Vendors may register on-line at https://www.ark.org/vendor/index.html.

### 3.2 GENERAL INFORMATION

- A. The State **shall not** lease any equipment or software for a period of time which continues past the end of a fiscal year unless the contract allows for cancellation by the State Procurement Official upon a 30-day written notice to the vendor/lessor in the event funds are not appropriated.
- B. The State **shall not** contract with another party to indemnify and defend that party for any liability and damages.
- C. The State **shall not** pay damages, legal expenses or other costs and expenses of any other party.
- D. The State shall not continue a contract once any equipment has been repossessed.
- E. Any litigation involving the State **must** take place in Pulaski County, Arkansas.
- F. The State **shall not** agree to any provision of a contract which violates the laws or constitution of the State of Arkansas.

G. The State **shall not** enter a contract which grants to another party any remedies other than the following:

- 1. The right to possession.
- 2. The right to accrued payments.
- 3. The right to expenses of deinstallation.
- 4. The right to expenses of repair to return the equipment to normal working order, normal wear and tear excluded.
- 5. The right to recover only amounts due at the time of repossession and any unamortized nonrecurring cost as allowed by Arkansas Law.
- H. The laws of the State of Arkansas **shall** govern this contract.
- I. A contract shall not be effective prior to award being made by a State Procurement Official.
- J. In a contract with another party, the State will accept the risk of loss of the equipment or software and pay for any destruction, loss or damage of the equipment or software while the State has such risk, when:
  - 1. The extent of liability for such risk is based upon the purchase price of the equipment or software at the time of any loss.
  - 2. The contract has required the State to carry insurance for such risk.

### 3.3 CONDITIONS OF CONTRACT

- A. The vendor **shall** at all times observe and comply with federal and State of Arkansas laws, local laws, ordinances, orders, and regulations existing at the time of, or enacted subsequent to the execution of a resulting contract which in any manner affect the completion of the work.
- B. The vendor shall indemnify and save harmless the agency and all its officers, representatives, agents, and employees against any claim or liability arising from or based upon the violation of any such law, ordinance, regulation, order or decree by an employee, representative, or subcontractor of the vendor.
- C. The Contractor agrees to the Performance-Based Contracting standards as presented in Attachment C, DHS Standard Terms and Conditions as presented in Attachment D, a pro forma contract as presented in Attachment E, the Business Associate Agreement as presented in Attachment F, and the Organizational or Personal Conflict of Interest policy as presented in Attachment G.

# ALL VENDOR STAFF MAY BE MANDATED REPORTERS UNDER STATE AND FEDERAL MANDATES

#### 3.4 STATEMENT OF LIABILITY

- A. The State will demonstrate reasonable care but will not be liable in the event of loss, destruction or theft of vendor-owned equipment or software and technical and business or operations literature to be delivered or to be used in the installation of deliverables and services. The vendor **shall** retain total liability for equipment, software and technical and business or operations literature. The State **shall** not at any time be responsible for or accept liability for any vendor-owned items.
- B. The vendor's liability for damages to the State **shall** be limited to the value of the Contract or five million dollars (\$5,000,000), whichever is higher. The foregoing limitation of liability **shall not** apply to claims for infringement of United States patent, copyright, trademarks or trade secrets; to claims for personal injury or damage to property caused by the gross negligence or willful misconduct of the vendor; to claims covered by other specific provisions of the Contract calling for damages; or to court costs or attorney's fees awarded by a court in addition to damages after litigation based on the Contract. The vendor and the State **shall not** be liable to each other, regardless of the form of action, for consequential, incidental, indirect, or special damages. This limitation of liability **shall not** apply to claims for infringement of United States patent, copyright, trademark or trade secrets; to claims for personal injury or damage to property caused by the gross negligence or willful misconduct of the vendor; to claims covered by other specific provisions of the Contract calling for damages; or to court costs or attorney's fees awarded by a court in addition to damages after litigation based on the Contract.
- C. Language in these terms and conditions **shall not** be construed or deemed as the State's waiver of its right of sovereign immunity. The vendor agrees that any claims against the State, whether sounding in tort or in

contract, **shall** be brought before the Arkansas State Claims Commission as provided by Arkansas law, and **shall** be governed accordingly.

### 3.5 RECORD RETENTION

A. The vendor **shall** maintain all pertinent financial and accounting records and evidence pertaining to the contract in accordance with generally accepted principles of accounting and as specified by the State of Arkansas Law. Upon request, access **shall** be granted to State or Federal Government entities or any of their duly authorized representatives.

- B. Financial and accounting records **shall** be made available, upon request, to the State of Arkansas's designee(s) at any time during the contract period and any extension thereof, and for five (5) years from expiration date and final payment on the contract or extension thereof.
- C. Other sections of this *Bid Solicitation* may contain additional requirements regarding record retention.

### 3.6 PRICE ESCALATION

- A. Price increases will be considered at the time of contract renewal.
- B. The vendor **must** provide to the Office of Procurement (OP) a written request for the price increase. The request **must** include supporting documentation demonstrating that the increase in contract price is based on an increase in market price. OP **shall** have the right to require additional information pertaining to the requested increase.
- C. Increases **shall not** be considered to increase profit or margins.
- D. OP **shall** have the right to approve or deny the request.

#### 3.7 CONFIDENTIALITY

- A. The vendor, vendor's subsidiaries, and vendor's employees **shall** be bound to all laws and to all requirements set forth in this *Bid Solicitation* concerning the confidentiality and secure handling of information of which they may become aware of while providing services under a resulting contract.
- B. Consistent and/or uncorrected breaches of confidentiality may constitute grounds for cancellation of a resulting contract, and the State **shall** have the right to cancel the contract on these grounds.
- C. Previous sections of this *Bid Solicitation* may contain additional confidentiality requirements.

# 3.8 CONTRACT INTERPRETATION

Should the State and vendor interpret specifications differently, either party may request clarification. However, if an agreement cannot be reached the determination of the State **shall** be final and controlling.

# 3.9 CANCELLATION

- A. <u>For Cause</u>. The State may cancel any contract resulting from this solicitation for cause at the discretion of the Arkansas Department of Human Services. The State **shall** give the vendor written notice of cancellation, specifying the terms and the effective date of contract termination.
- B. <u>For Convenience</u>. The State may cancel any contract resulting from the solicitation by giving the Contractor written notice of such cancellation no less than thirty (30) days prior to the date of cancellation.
- C. If upon cancellation the Contractor has provided commodities or services which the State of Arkansas has accepted, and there are no funds legally available to pay for the commodities or services, the Contractor may file a claim with the Arkansas Claims Commission under the laws and regulations governing the filing of such claims.

# 3.10 SEVERABILITY

If any provision of the contract, including items incorporated by reference, is declared or found to be illegal, unenforceable, or void, then both the agency and the vendor **shall** be relieved of all obligations arising under such

provision. If the remainder of the contract is capable of performance, it **shall not** be affected by such declaration or finding and **shall** be fully performed.

# **SECTION 4 – STANDARD TERMS AND CONDITIONS**

- **Do not** provide responses to items in this section.
- GENERAL: Any special terms and conditions included in this solicitation shall override these Standard Terms and Conditions. The Standard Terms and Conditions and any special terms and conditions shall become part of any contract entered into if any or all parts of the bid are accepted by the State of Arkansas.
- 2. ACCEPTANCE AND REJECTION: The State shall have the right to accept or reject all or any part of a bid or any and all bids, to waive minor technicalities, and to award the bid to best serve the interest of the State.
- 3. **BID SUBMISSION**: Original Bid Packets **must** be submitted to the Office of State Procurement on or before the date and time specified for bid opening. The Bid Packet **must** contain all documents, information, and attachments as specifically and expressly required in the *Bid Solicitation*. The bid **must** be typed or printed in ink. The signature **must** be in ink. Unsigned bids **shall** be disqualified. The person signing the bid should show title or authority to bind the firm in a contract. Multiple bids **must** be placed in separate packages and should be completely and properly identified. Late bids **shall not** be considered under any circumstances.
- 4. PRICES: Bid unit price F.O.B. destination. In case of errors in extension, unit prices **shall** govern. Prices **shall** be firm and **shall not** be subject to escalation unless otherwise specified in the *Bid Solicitation*. Unless otherwise specified, the bid **must** be firm for acceptance for thirty (30) days from the bid opening date. "Discount from list" bids are not acceptable unless requested in the *Bid Solicitation*.
- 5. **QUANTITIES**: Quantities stated in a *Bid Solicitation* for term contracts are estimates only and are not guaranteed. Contractors **must** bid unit price on the estimated quantity and unit of measure specified. The State may order more or less than the estimated quantity on term contracts. Quantities stated on firm contracts are actual Requirements of the ordering agency.
- 6. BRAND NAME REFERENCES: Unless otherwise specified in the *Bid Solicitation*, any catalog brand name or manufacturer reference used in the *Bid Solicitation* is descriptive only, not restrictive, and used to indicate the type and quality desired. Bids on brands of like nature and quality will be considered. If bidding on other than referenced specifications, the bid **must** show the manufacturer, brand or trade name, and other descriptions, and should include the manufacturer's illustrations and complete descriptions of the product offered. The State **shall** have the right to determine whether a substitute offered is equivalent to and meets the standards of the item specified, and the State may require the Contractor to supply additional descriptive material. The Contractor **shall** guarantee that the product offered will meet or exceed specifications identified in this *Bid Solicitation*. Contractors not bidding an alternate to the referenced brand name or manufacturer **shall** be required to furnish the product according to brand names, numbers, etc., as specified in the solicitation.
- 7. GUARANTY: All items bid shall be newly manufactured, in first-class condition, latest model and design, including, where applicable, containers suitable for shipment and storage, unless otherwise indicated in the Bid Solicitation. The Contractor hereby guarantees that everything furnished hereunder shall be free from defects in design, workmanship and material, that if sold by drawing, sample or specification, it shall conform thereto and shall serve the function for which it was furnished. The Contractor shall further guarantee that if the items furnished hereunder are to be installed by the Contractor, such items shall function properly when installed. The Contractor shall guarantee that all applicable laws have been complied with relating to construction, packaging, labeling and registration. The Contractor's obligations under this paragraph shall survive for a period of one (1) year from the date of delivery, unless otherwise specified herein.
- 8. SAMPLES: Samples or demonstrators, when requested, **must** be furnished free of expense to the State. Each sample should be marked with the Contractor's name and address, bid or contract number and item number. If requested, samples that are not destroyed during reasonable examination will be returned at Contractor's expense. After reasonable examination, all demonstrators will be returned at Contractor's expense.
- 9. TESTING PROCEDURES FOR SPECIFICATIONS COMPLIANCE: Tests may be performed on samples or demonstrators submitted with the bid or on samples taken from the regular shipment. In the event products tested fail to meet or exceed all conditions and requirements of the specifications, the cost of the sample used, and the reasonable cost of the testing shall be borne by the Contractor.
- 10. AMENDMENTS: Contractor's bids cannot be altered or amended after the bid opening except as permitted by regulation.
- 11. TAXES AND TRADE DISCOUNTS: Do not include State or local sales taxes in the bid price. Trade discounts should be deducted from the unit price and the net price should be shown in the bid.
- 12. AWARD: Term Contract: A contract award will be issued to the successful Contractor. It results in a binding obligation without further action by either party. This award does not authorize shipment. Shipment is authorized by the receipt of a purchase order from the ordering agency. Firm Contract: A written State purchase order authorizing shipment will be furnished to the successful Contractor.

13. DELIVERY ON FIRM CONTRACTS: This solicitation shows the number of days to place a commodity in the ordering agency's designated location under normal conditions. If the Contractor cannot meet the stated delivery, alternate delivery schedules may become a factor in an award. The Office of State Procurement shall have the right to extend delivery if reasons appear valid. If the date is not acceptable, the agency may buy elsewhere, and any additional cost shall be borne by the Contractor.

- 14. **DELIVERY REQUIREMENTS**: No substitutions or cancellations are permitted without written approval of the Office of State Procurement. Delivery **shall** be made during agency work hours (8:00 a.m. to 4:30 p.m. Central Time) unless prior approval for other delivery has been obtained from the agency. Packing memoranda **shall** be enclosed with each shipment.
- **15. STORAGE**: The ordering agency is responsible for storage if the Contractor delivers within the time required and the agency cannot accept delivery.
- 16. **DEFAULT**: All commodities furnished **shall** be subject to inspection and acceptance of the ordering agency after delivery. Back orders, default in promised delivery, or failure to meet specifications **shall** authorize the Office of State Procurement to cancel this contract or any portion of it and reasonably purchase commodities elsewhere and charge full increase, if any, in cost and handling to the defaulting Contractor. The Contractor **must** give written notice to the Office of State Procurement and ordering agency of the reason and the expected delivery date. Consistent failure to meet delivery without a valid reason may cause removal from the Contractors list or suspension of eligibility for award.
- 17. VARIATION IN QUANTITY: The State assumes no liability for commodities produced, processed or shipped in excess of the amount specified on the agency's purchase order.
- **18. INVOICING**: The Contractor **shall** be paid upon the completion of all of the following: (1) submission of an original and the specified number of copies of a properly itemized invoice showing the bid and purchase order numbers, where itemized in the *Bid Solicitation*; (2) delivery and acceptance of the commodities; (3) proper and legal processing of the invoice by all necessary State agencies. Invoices **must** be sent to the "Invoice To" point shown on the purchase order.
- 19. STATE PROPERTY: Any specifications, drawings, technical information, dies, cuts, negatives, positives, data or any other commodity furnished to the Contractor hereunder or in contemplation hereof or developed by the Contractor for use hereunder shall remain property of the State, shall be kept confidential, shall be used only as expressly authorized, and shall be returned at the Contractor's expense to the F.O.B. point provided by the agency or by OSP. Contractor shall properly identify items being returned.
- 20. PATENTS OR COPYRIGHTS: The Contractor must agree to indemnify and hold the State harmless from all claims, damages and costs including attorneys' fees, arising from infringement of patents or copyrights.
- 21. ASSIGNMENT: Any contract entered into pursuant to this solicitation shall not be assignable nor the duties thereunder delegable by either party without the written consent of the other party of the contract.
- 22. CLAIMS: Any claims the Contractor may assert under this Agreement shall be brought before the Arkansas State Claims Commission ("Commission"), which shall have exclusive jurisdiction over all claims that the Contactor may have arising from or in connection with this Agreement. Unless the Contractor's obligations to perform are terminated by the State, the Contractor shall continue to provide the Services under this Agreement even if the Contractor has a claim pending before the Commission.
- 23. CANCELLATION: In the event, the State no longer needs the commodities or services specified for any reason, (e.g., program changes; changes in laws, rules or regulations; relocation of offices; lack of appropriated funding, etc.), the State shall have the right to cancel the contract or purchase order by giving the Contractor written notice of such cancellation thirty (30) days prior to the date of cancellation.
  - Any delivered but unpaid for goods will be returned in normal condition to the Contractor by the State. If the State is unable to return the commodities in normal condition and there are no funds legally available to pay for the goods, the Contractor may file a claim with the Arkansas Claims Commission under the laws and regulations governing the filing of such claims. If upon cancellation the Contractor has provided services which the State has accepted, the Contractor may file a claim. **NOTHING IN THIS CONTRACT SHALL BE DEEMED A WAIVER OF THE STATE'S RIGHT TO SOVEREIGN IMMUNITY.**
- 24. **DISCRIMINATION**: In order to comply with the provision of Act 954 of 1977 relating to unfair employment practices, the Contractor agrees that: (a) the Contractor **shall not** discriminate against any employee or applicant for employment because of race, sex, color, age, religion, handicap, or national origin; (b) in all solicitations or advertisements for employees, the Contractor **shall** state that all qualified applicants **shall** receive consideration without regard to race, color, sex, age, religion, handicap, or national origin; (c) the Contractor will furnish such relevant information and reports as requested by the Human Resources Commission for the purpose of determining compliance with the statute; (d) failure of the Contractor to comply with the statute, the rules and regulations promulgated thereunder and this nondiscrimination clause **shall** be deemed a breach of contract and it may be cancelled, terminated or suspended in whole or in part; (e) the Contractor **shall** include the provisions of above items (a) through (d) in every subcontract so that such provisions **shall** be binding upon such subcontractor Contractor.
- **25. CONTINGENT FEE**: The Contractor guarantees that no one has been retained to solicit or secure this contract upon an agreement or understanding for a commission, percentage, brokerage or contingent fee, except for retention of bona fide employees or bona fide established commercial selling agencies maintained by the Contractor for securing business.

26. ANTITRUST ASSIGNMENT: As part of the consideration for entering into any contract pursuant to this solicitation, the Contractor named on the *Bid Signature Page* for this solicitation, acting herein by the authorized individual or its duly authorized agent, hereby assigns, sells and transfers to the State of Arkansas all rights, title and interest in and to all causes of action it may have under the antitrust laws of the United States or this State for price fixing, which causes of action have accrued prior to the date of this assignment and which relate solely to the particular goods or services purchased or produced by this State pursuant to this contract.

**27. DISCLOSURE**: Failure to make any disclosure required by Governor's Executive Order 98-04, or any violation of any rule, regulation, or policy adopted pursuant to that order, **shall** be a material breach of the terms of this contract. Any Contractor, whether an individual or entity, who fails to make the required disclosure or who violates any rule, regulation, or policy **shall** be subject to all legal remedies available to the agency.
