Scope of Work

Communication Plus+ has a long, 30+ year history and experience and familiarity with the scope of work and the type of service contract through DHS, as well as the reputation to continue to successfully handle this challenging project. Since 1986, Communication Plus+ has worked closely with DHS and the passage of the Americans with Disability Act (ADA) in 1990 prompted the first formal contractual agreement with DHS in 1991.

Our extensive 30+ years of experience providing interpreting services in the public and private sectors include interpreters for all settings and occasions. We provide consultation and training opportunities regarding the Americans with Disabilities Act (ADA), simultaneous and consecutive interpreting protocols, sight translation protocol, and cross-cultural interactions.

Communication Plus+ priority and standard operating procedure is to match the qualifications of interpreters for each assignment or event requested based on the setting and needs of the consumers involved. Communication Plus+'s familiarity with DHS and its clients allows for the gathering of relevant information for each request form the contact person in order to assure a good match according to these standard procedures. Interpreters are recruited and selected, and subsequently assigned subject to their availability and acceptance of the assignment(s).

All services properly requested will be performed as required. Under standard procedures, a call is received for services and each request is handled on an individual basis to gain information regarding the service date and time, length of the assignment or event, location, name of consumers, purpose, number of interpreters needed, and name and contact information of the contact person and on-site contact person. This information is sued to select and assign interpreters, provide interpreters with all the necessary details to perform the service, inform the initial contact person that an interpreter has been scheduled, and invoice DHS upon completion of the assignment.

Over the years, Communication plus has exceeded DHS expectations and Performance Indicators and has demonstrated capability in providing services 100% of the time for all DHS divisions. All requests were fulfilled, regardless of the length of time it required to work out schedules to fill job requests, including those considered Emergency/Crisis with less than 24 hours' notice. Communication Plus+ understands the need to safeguard Protected Health Information (PHI) under HIPAA and will execute Business Associate Agreements as needed. Communication Plus+ can provide Video Remote Interpreting (VRI) services through our own platform that is HIPAA-compliant and encrypted end-to-end or we can utilize a platform provided by DHS if the agency prefers to do so. Communication Plus+ has been providing video remote interpreting services since 2018 while Mr. Gorum personally began providing video interpreting services in 2005.

Communication Plus+, unlike many other interpreting services agencies, does not utilize "email blasts" to offer interpreting assignments to service providers. Instead, we look at the demands for each request including content, division involved, the client's preferred language or mode of communication, etc. and match the service provider who can best meet those demands. We operate in strict compliance with Arkansas' interpreter licensure law which provides guidance as to what certification or credential an interpreter must hold in order to provide service in a particular setting. Many of the interpreters utilized by Communication Plus+ have training in specialized settings such as mental health interpreting or legal interpreting, making them ideal for interpreting in situations such as the Arkansas State Hospital or DCFS staffings.

Communication Plus+ verifies and maintains records of all interpreters' resumes, licenses, and certification/credentials. Licenses issued by the Arkansas Department of Health must be renewed each calendar year. Quality Assurance Screening Test (QAST) credentials must also be renewed each calendar year while Registry of Interpreters for the Deaf certifications must be renewed annually with the expiration date being June 30th annually.

Other Contract Requirements

Interpreters assigned by Communication Plus+ are of the highest quality, professionally trained, operate in full compliance with the Arkansas interpreter licensure law, and adhere to the RID/NAD Code of Professional Conduct.

RID/NAD certified and or QAST credentialed interpreters are qualified to interpret effectively, accurately, impartially, exercise discretion, and always adhere to the NAD-RID Code of Professional Conduct. Additionally, these interpreters sign confidentiality statements annually.

Interpreters holding an Arkansas interpreter license must maintain their certifications or credentials and must provide proof of said maintenance when applying for annual license renewal. RID/NAD certified interpreters must complete 8.0 CEUS (80 clock hours) of RID-approved professional development every four years while QAST-credentialed interpreters must earn 1.0 CEUS (10 clock hours) of Arkansas Rehabilitation Services-approved professional development every year. Interpreters holding a QAST level 1 through 3 must be reevaluated/retested every two years. Interpreters holding a QAST Level 4 must be reevaluated/retested every five years. Interpreters holding a QAST level 5 do not have to be regularly reevaluated/retested but must abide by the requirement to earn 1.0 CEUS (10 clock hours) annually to maintain their credential.
