Infinity Therapy Price Justification

A. Speech-Language Therapy

The speech-language therapy bid price was determined by industry standards and the average Medicaid/Medicare reimbursement rates.

- The average Medicaid and Medicare speech-language reimbursement rates were calculated to determine the speech-language therapy bid price of \$82.00 per hour.
- The Medicaid reimbursement rate for code 92507; individual treatment of speech, language, voice, communication, and/or auditory processing disorder is \$21.76 per unit (15 minutes) = \$87.04 per hour.
- The Medicare reimbursement rate for code 92507; individual treatment of speech, language, voice, communication, and/or auditory processing disorder is \$78.16 per session (not time-based).
- The speech-language therapy bid price of \$82.00 was determined by calculating the average of the Medicaid and Medicare reimbursement rates (\$82.60) and slightly adjusting for quantity of services.

B. Speech-Language Evaluations

The speech-language evaluation bid price was determined by industry standards and the average Medicaid/Medicare reimbursement rates.

- The average Medicaid and Medicare speech-language evaluation rates were calculated and adjusted for quantity to determine the evaluation bid price of \$170.00 per hour.
- The Medicaid reimbursement rate for code 92522; Evaluation of speech sound production (e.g., articulation, phonological process, apraxia, dysarthria) and 92523 with evaluation of language comprehension and expression (e.g., receptive and expressive language) is \$49.44 per unit (30 minutes) = \$98.88 per hour. The standard length of a speech-language evaluation is 1.5-2 hours which would range between \$148.32-\$197.76 per evaluation.
- The Medicare reimbursement rate for code 92522 Evaluation of speech sound production (e.g., articulation, phonological process, apraxia, dysarthria) is \$114.45 per evaluation (not time-based) and 92523 with evaluation of language comprehension and expression (e.g., receptive and expressive language) is \$235.18 per evaluation (not time-based).
- The speech-language evaluation bid price of \$170.00 was determined by calculating the average of the Medicaid and Medicare reimbursement rates (\$173.93) and adjusting for quantity of services.
